**National Workers' Comp Defense Firm Earns Top Ranking from Law360**

NEW YORK, April 21, 2015 – Law360, a leading publication covering law firms and legal developments, has ranked Adelson, Testan, Brundo, Novell & Jimenez (ATB) as the country's top law firm for female attorneys.
