#### **National Workers' Comp Defense Firm Cited by Law360 For High Percentage of Female Partners and Attorneys**

NEW YORK, April 21, 2016 – *Law360*, a leading publication covering law firms and legal developments, has ranked Adelson, Testan, Brundo, Novell & Jimenez (ATB) as the country's fifth best law firm for female partners and eighth best for female attorneys.

According to *Law360*, women make up 34 percent of all attorneys at U.S. law firms, as well as 44 percent of non-partners and just 22 percent of partners. However, at ATB, women attorneys account for 45 percent of the firm's attorneys, 48 percent of partners and 60 percent of equity partners.

The *Law360* ranking, *The 25 Best Law Firms for Female Partners*, is based on the percentage of female equity and non-equity partners at more than 300 U.S. law firms and can be found at <http://www.law360.com/articles/784695?sidebar=true>.

Its 2016 ranking of the *Top 100 Law Firms for Female Attorneys*, drawn from the same 300 firms, uses a variety of metrics, including: percentage of partners and non-partners who are women; the percentage of associate-level attorneys who are women; and the divide between the two.
